PROFESSIONAL EXPERIENCE

Private Practice (3/93 to present).

Private practice specializing in the forensic and clinical neuropsychological and psychological assessment of children, adolescents and adults. Scope of practice includes cases involving post-traumatic stress and other psychiatric disorders, head injuries, memory disorders, attention disorders, autistic spectrum and other developmental disorders, learning disorders, genetic disorders affecting neurocognitive functioning, hematology/oncology, seizure disorders and other neurological disorders. Conducted IME's, consulted and served as an Expert Witness in approximately 125 cases.

Recent forensic cases have included serving as a consultant and expert witness on a variety of individual and multi-plaintiff civil and criminal cases for both plaintiff and defense attorneys. These have included multiple personal injury cases with allegations of sexual abuse with resultant emotional damages, a liability case for the SF US Attorney's Office involving a motor vehicle accident with claims of a head injury causing significantly decreased cognitive, memory, occupational and social functioning; a criminal case involving claims of mitigating psychiatric and learning disorders; a criminal tax evasion case involving claims of a mitigating personality disorder; multiple personal injury

cases involving claims of PTSD and/or head injuries; a civil case against the California Board of Education and a CA school district involving alleged violation of educational rights, as well as multiple cases involving various
