Examined how participation in a therapy program that combines Dialectical Behavior Therapy, cognitive behavioral techniques, and traditional vestibular rehabilitation affects patients with vestibular problems in terms of symptoms, coping, and physical/emotional functioning. This was a long-term project following the patients that participated in the Neurotology panel at Kaiser Permanente Santa Rosa. Findings suggested that participation improves patients' perception of coping and physical functioning and decreases utilization of emergency services and specialty clinics.

Examined the links between elements in popular culture and rape myth acceptance. Specifically, utilized an information processing perspective to assess how romanticized violence in the cover image and texts of romance novels affects women's judgments about rape in legal situations. Data collection involved experimental priming of romance novel covers and written rape scenes, with follow-up questionnaires. As predicted, exposure to images and scenes that codify rape myths led to increased victim-blaming by participants.

As predicted, participants in the "rape myth" condition were more victim-blaming than comparison subjects, attributing greater responsibility to the victim for her being raped. Responsibilities included all phases of the research, including conceptualization, design, analyses, and write up.
